BUSINESS

1. Vale – Minute silence for members who have passed
2. Confirmation of the minutes of the previous general meeting
3. To receive and consider the Presidents' and General Manager's reports.
4. To receive and consider the Financial Report and Auditor's report.
5. To declare elected the Directors.
6. To confirm in retrospect the Auditor's remuneration.
7. The members consider and approve Ordinary Resolution 1, to retrospectively approve expenditure for the period from the date of the proposed and deferred 2020 AGM to the date of the 2021 AGM as set out in the attached information.
8. A reasonable opportunity shall be allowed for the members as a whole to ask questions about, or make comments on, the management of the club.
9. Members may submit a written question to the auditor if the question is relevant to the content of the auditor's report. The question shall be submitted no later than five (5) business days before the annual general meeting.
10. The club's auditor may be heard on any part of the accounts including the process of the club's audit.

ORDINARY RESOLUTION 1.

That pursuant to the Registered Clubs Act:

The members hereby approve and agree retrospectively for the period from the date of the proposed and deferred 2020 AGM to the date of the 2021 AGM to reasonable expenses for the Board of Directors in a sum not exceeding \$20,000 for the previous year, for the following expenses subject to the approval by the Board of Directors:

- (a) The reasonable cost of beverages for each Director, whenever they are duly performing at the club.
- (b) The reasonable expense of safe transport incurred in traveling to the club for meetings and other functions as required and approved by the Board.
- (c) The reasonable expense incurred by Directors either within or elsewhere in relation to such duties including entertainment of special guests of the Club and other promotional duties as approved by the Board.
- (d) The reasonable expenses of supply of Christmas fare to the Directors as approved by the Board.
- (e) The reasonable costs of Directors and/or Officers attending meetings of other Associations of which the club is a member.
- (f) The reasonable cost of attendance at functions with partners where appropriate and required to represent the club and authorised by the Board to do so.
- (g) The reasonable cost of Directors and or Officers attending at the Registered Clubs Association and Clubs NSW AGM, conferences and Trade Exhibitions.
- (h) The reasonable cost of issuing each Director clothing apparel for wear while representing the club.
- (i) The reasonable cost of Directors attending other clubs, lectures, trade displays and organized study programs and fact finding visits as approved by the Board.

The members acknowledge that the benefits as listed above are not available to members generally, but only for those who are Directors and/or Officers of the Club and those members who are directly involved in the above activities.

Explanatory Notes – Ordinary Resolution 1

1. Due to the Covid19 Public Health Orders and direction given by the Department of Fair Trading's Registry of Associations and Co-operatives the 2020 AGM was postponed. The expenditure set out in the Ordinary Resolution is normally approved in advance, but for the period from the date of the proposed and deferred 2020 AGM to the date of the 2021 AGM this was not possible. Members are now being asked to approve the expenditure at the deferred 2020 AGM.
2. Members normally approve an amount of "up to \$20,000". The actual expenditure in the period was under \$9,000, less than half the usual limits.
3. Under the Registered Clubs Act 1976 (NSW)(Registered Clubs Act) benefits may only be given to Directors and others representing the Club, which are not also available to every Full Member of the Club, when those benefits are approved by ordinary resolution of the members.

Notes to Members

1. All Life members and active Ordinary members are entitled to attend the AGM.
2. To be passed, the Ordinary Resolution must receive votes in its favour from not less than a majority (50% + 1) of those Life members and active Ordinary members who are present and vote in person at the AGM.
3. As a result of the provisions in the Co-operative (Adoption of the National Law) Act relating to notice of general meetings, the Ordinary Resolution must be considered as a whole and cannot be altered by motions from the floor of the AGM.
4. Members of the Club, who are employees of the Club, cannot vote at the AGM.
5. Members should read the proposed Ordinary Resolution 1 and the Explanatory Notes above about the resolution, which explains the nature and effect of the Ordinary Resolution 1.
6. Proxy Votes are not allowed under the Registered Clubs Act 1976.
